What expenses can I claim?

As an employee of i4 Pay Partners' Umbrella Company you are entitled to claim legitimate business expenses, which are costs that have been incurred whilst performing your business duties.

i4 Pay Partners' Umbrella Company does not need to deduct personal tax or national insurance on the value of your business expense claims and as a result this is an effective way of reducing your taxable income, therefore increasing your net earnings.

For example, if you claim £100 worth of expenses against your gross income of £500 the tax would only be payable on £400.

Working through i4's Umbrella Company you are able to claim the following list of HMRC approved business expenses:

TRAVEL between your home and your temporary place of work

MILEAGE between your home and temporary place of work

SUBSISTENCE covers the cost of meals and drinks whilst working in a temporary workplace

ACCOMMODATION when you have to stay away from home for work purposes

PERSONAL INCIDENTAL EXPENSES covers the cost of miscellaneous expenses when staying away from home for work purposes

HOME WORKING ALLOWANCE covers miscellaneous expenses when you are working from home

SPECIALIST CLOTHING includes uniforms and protective clothing

HOME AND MOBILE TELEPHONE BILLS can be claimed for all business calls

PROFESSIONAL SUBSCRIPTIONS to join your relevant institutions

NON-UK NATIONALS may be entitled to additional expenses.
